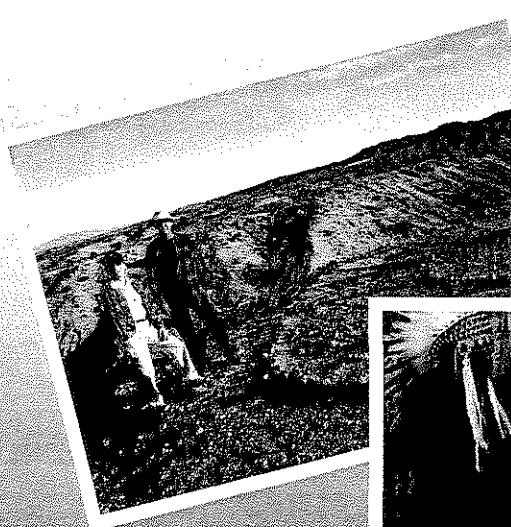
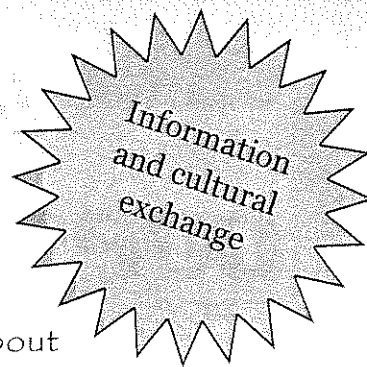

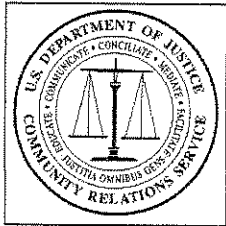
## Meet the Federal Partners

In this session, you'll meet staff from federal agencies and partner organizations that impact Indian country. Here's your chance to find out how they work and share with them a little about who you are, your Tribe, and your interests. Don't forget to ask about opportunities for Native Americans and Alaska Natives. Youth are encouraged to meet with 5-6 different federal partners during the session. We'll signal at 15 minute increments to help you manage your time.



# Federal Partners



## Community Relations Service (CRS) Daphne Felten-Green, *Senior Counsel*

CRS is the "peacemaker" for community conflicts and tensions arising from differences of race, color and national origin. The agency seeks to prevent and respond to alleged violent hate crimes committed on the basis of: gender, gender identity, sexual orientation, religion, disability, race, color, and national origin.



## U.S. Department of Agriculture (USDA)

The United States Department of Agriculture provides leadership on food, agriculture, natural resources, and related issues based on sound public policy, the best available science, and efficient management.



## Community Oriented Policing Services (COPS) Matthew Lysakowski, *Senior Advisor for Tribal Affairs*

COPS advances the practice of community policing in America's state, local and tribal law enforcement agencies. COPS shares information and makes grants to police departments around the United States. Community policing is a philosophy that promotes the use of partnerships and problem-solving techniques to proactively address the immediate conditions that give rise to public safety issues — crime, social disorder and fear of crime.



## Indian Health Service (IHS) Skye Bass, MSW, *Public Health Advisor*

Indian Health Service provides a comprehensive health service delivery system for approximately 2 million American Indian and Alaska Native people residing on or near reservations. Indian Health Service serves members of Federally recognized Tribes across rural and urban areas of the United States.



## Office of National Drug Control Policy (ONDCP) Katie Greene, *Associate Director Office of Intergovernmental and Public Liaison*

ONDCP was created by the Anti-Drug Abuse Act of 1988. ONDCP advises the President on drug-control issues, coordinates drug-control activities and related funding across the Federal government, and produces the annual National Drug Control Strategy, which outlines Administration efforts to reduce illicit drug use, manufacturing and trafficking, drug-related crime and violence, and drug-related health consequences.



## Substance Abuse & Mental Health Services Administration (SAMHSA) CDR Josefine Haynes-Battle, MSN, BSN, RN, *Public Health Analyst & Project Officer*

SAMHSA's mission is to reduce the impact of substance abuse and mental illness on America's communities. The agency provides leadership and devotes its resources — programs, policies, information and data, contracts and grants— toward helping the Nation act on the knowledge that Behavioral Health is essential; prevention works; treatment is effective; and people recover from mental and substance use disorders.



## Center for Native American Youth (CNAY) Erin Bailey, *Director*

The Center for Native American Youth is raising awareness on issues facing Native Youth and working to share resources (scholarships, internships, youth organizations, etc.) - we need you to be part of the conversation!

**Department of Energy (DOE)**  
Jody TallBear, *Attorney Advisor*

DOE's mission is to ensure America's security and prosperity by addressing its energy, environmental, and nuclear challenges through transformative science and technology solutions. It has a large footprint in Indian Country and plays an important role in protecting the country's nuclear arsenal as well as promoting science, research, and STEM education.

**Advisory Council on Historic Preservation (ACHP), Office of Native American Affairs**  
Valerie Hauser, *Director, Office of Native American Affairs*

ACHP oversees a federal preservation review process in which Indian tribes have the opportunity to influence federal decision making when federal projects may affect sacred places and historic properties of religious and cultural significance. Meet and talk with the staff who advises both federal agencies and Indian tribes about protection of sacred and historical places.

**Administration for Native Americans (ANA)**

ANA promotes self-sufficiency for Native Americans by providing discretionary grant funding for community based project, and training and technical assistance to eligible tribes and native organizations. We believe community members are at the heart of lasting and positive change.

**U.S. Census Bureau**

The Bureau is responsible for conducting the United States Census and other national demographic and economic surveys. It collects and publishes demographic and economic information about the Nation's American Indian and Alaska Native populations and also collects and publishes information regarding the boundaries and economies of tribal lands.

**Environment and Natural Resources Division**

The **Environment and Natural Resources Division** is responsible for the civil and criminal enforcement of environmental laws, the defense of the Government's administration of Federal environmental laws, and litigation relating to the use and protection of Federally-owned public lands and natural resources.

**Federal Bureau of Investigation**  
Monica McLean, *Supervisory Special Agent (HQ)*

The FBI is dedicated to protecting and defending the United States against terrorist and foreign Intelligence threats, enforcing criminal laws, and providing leadership and criminal justice services to federal, state, and tribal partners. It has internship opportunities available for college undergraduate and graduate students, and recruits individuals with a wide variety of work experiences.
